FESTIVAL GOALS

Popularization of various gymnastics and dance forms

- Developing cultural and artistic activity among children and youth
- Developing healthy competition
- Creating conditions for the exchange of ideas and experiences when working with children and youth

CATEGORIES AND RULES OF PARTICIPATION

- 1. The Festival is intended for out-of-school and school institutions as well as private individuals who are active in the amateur movement of rhythmic gymnastics, sports gymnastics, acrobatic gymnastics and other forms of gymnastics and dance.
- 2. The Festival will be held in two competitions: gymnastics and dance in the following age categories and forms.

GIMNASTICS COMPETITION (choreographies containing elements of artistic, sports and acrobatic gymnastics using artistic gymnastics equipment or dance props).

- up to 9 years old (born in 2016 and younger)
- 10-13 years old (born in 2015-2012)
- 14-25 years old (born in 2011-2000)

Forms: - Duets

- Mini formations (3-7 participants)
- Formations (8-50 participants)

DANCE COMPETITION (choreographies including elements of jazz dance, modern dance, hip-hop, ballroom dance, folk dance, disco dance and others without requiring the use of gymnastic equipment or dance props).

- up to 9 years old (born in 2016 and younger)
- 10-13 years old (born in 2015-2012)
- 14-25 years old (born in 2011-2000)

Forms: - Duets

- Mini formations (3-7 participants)
- Formations (8-50 participants)

The year of birth of most participants determines the assignment to a given age category. If the number of older participants in a formation, mini formation or a duet is equal to the younger ones, they should be registered in the older age category.

- 3. Participants and guardians are required to have a valid identity document or other document confirming the participant's age (school/student ID).
- 4. Each institution or individual may enter any number of duets, mini formations and formations in each competition and age category.
- 5. In a gymnastics or dance competition, a given duet, mini-formation or formation may present only one choreography in its age category.
- 6. The Organizer has the right to combine age categories and dance forms.
- 7. Duration of the performances:
 - duets performances: up to 2 minutes maximum
 - mini formation performances: from 2 minutes to 3 minutes maximum
 - formation performances: from 2 minutes to 5 minutes maximum

8. Music

The name of the music file, in WAV or MP3 format, should include the following information: names of the duet members/name of the mini formation/formation – name of the institution – age category – competition, e.g.: Muszelki formation – MDK Gdynia – up to 9 years old – gymnastics competition. The file must be sent by e-mail **by May 10, 2025** to the following address: gimshow@mdk.gdynia.pl (additionally, it is necessary to have a copy of the music file on a USB pen drive in WAV or MP3 format on the day of the Festival).

- 9. The cost of accreditation for participation in the "Gim-Show 2025" Festival is:
 - •PLN 100 or 25 Euro for the participant's first performance
 - PLN 70 or 15 Euro for the participant's each subsequent performance

The accreditation does not apply to instructors and carers.

The accreditation must be paid **by April 01, 2025** to the account of the Youth Community Center: **46 1440 1026 0000 0000 1253 0625** as:

"Gim-Show 2025" accreditation, name of the institution, surnames and names of the duets members, name of the mini formation or formation, number of people in the team, competition (gymnastics/dance), age category.

- 10. The condition to participate in the Festival is to send via e-mail to the following address: gimshow@mdk.gdynia.pl no later than April 01, 2025 the following documents:
 - correctly filled out and signed "Registration Form"
 - confirmation of accreditation payment

IMPORTANT!

- Applications should be sent by e-mail with the name of the applying institution in the subject of the message.
- Each performance of a duet, mini-formation or formation must be reported on a separate Registration Forms.
- Lack of the complete set of documents and attachments may result in rejection of the application.
- 11. The originals of the Registration Forms, consents and declarations of the participant/instructor/applicant signed by hand must be delivered to the Organizer no later than on the day of the Festival when registering the teams. Consents and declarations in the case of minor participants should be signed by their parents or legal guardians, and in the case of adult participants, by themselves.
- 12. Signing the declaration and expressing the consents attached to the Registration Form is voluntary, but necessary to participate in the Festival.
- 13. In case of resignation from participation in the Festival, the accreditation cost is not refundable.
- 14. Incorrectly filled out Registration Form or failure to properly sign the consents and declarations regarding the protection of personal data will result in disqualification of the participant.
- 15. The Festival performances will take place on a gymnastics carpet. All performances will only be allowed in ballet flats, toe shoes, socks, barefoot or alternative sports footwear.

JURY

- 1. The performances will be assessed by a jury selected by the Organizer.
- 2. In its assessment, the Jury will take into account:
 - gymnastics elements,
 - dance elements,
 - choreography,
 - variety of settings,
 - synchronization of movements,
 - expression and dynamics of movements.
 - artistic expression.
- 3. The Jury's decisions are final and indisputable.

PRIZES

- 1. The jury may award:
 - Grand Prix of the festival "Gim-Show 2025" with a financial prize of PLN 5,000.00
 - 1st, 2nd and 3rd places and distinctions in each competition and age category
 - special prizes
- 2. Each participant and instructor will receive a commemorative T-shirt with the "Gim Show 2025" Festival logo.

ORGANISATIONAL RULES

- 1. The detailed program of the Festival along with the order of performances will be posted on the website of the Youth Community Center in Gdynia www.mdk.gdynia.pl no later than 3 days before the Festival.
- 2. Institutions or persons delegating participants are obliged to insure each delegated participant for the duration of their travel and stay at the Festival.
- 3. Festival participants arrive at their own expense.
- 4. The Organizer does not provide accommodation or meals.
- 5. The Organizer provides sound equipment.
- 6. The Organizer reserves the right to present photos and videos taken during the Festival free of charge via the media channels and on the website, Facebook and YouTube channel of the Center, as well as to publish the names and surnames of trainers and Festival participants, no longer than 2 years from the following year after the competition ends. Appropriate consents and declarations are included on the Registration Form.
- 7. A person registering a formation for the Festival is obliged to correctly provide the author of the lyrics and music composer as well as the titles of the pieces used during the performance in the Registration Form. Providing unreliable, incomplete information (in particular the authors of music and lyrics) will result in rejection of the application. The accuracy of the data rests with the person completing the form.
- 8. The Organizer stipulates that Festival participants are obliged to use songs, artistic performances and phonograms while respecting the copyrights or related rights of their authors, performers and producers.
- 9. The Organizer is not responsible for items left in the dressing rooms or lost in the hall.
- 10. The Organizer reserves the right to change the regulations, change the date or cancel the Festival without giving a reason.
- 11. Everyone attending the Festival is obliged to follow the Organizer's recommendations as well as fire protection.and health and safety regulations.
- 12. Information regarding the protection of personal data are included in the Information Clause attached to this Regulations document Annex No. 1 to the Regulations.

Annex no 1 to the Gim-Show 2025 regulations Information regarding the processing of personal data

INFORMATION CLAUSE

- 1. The administrator, i.e. the entity deciding which personal data will be processed and for what purposes and in what ways, is the Youth Community Center with its registered office in Gdynia at 2 Grabowo Street, telephone no.: (58) 698 86 18, e-mail address: biuro@mdk.gdynia.pl.
- 2. In all matters relating to the protection of personal data, you have the right to contact our Data Protection Officer at the address of the administrator's registered office or at the e-mail address: iod.edukacja@gdynia.pl.
- 3. The basis for the processing of your personal data is your consent to the processing of personal data Article 6, section 1, letter a of GDPR. Your data will be processed for the purpose of organizing, preparing, conducting and promoting: "GIM-SHOW 2025", the 19th INTERNATIONAL GYMNASTICS AND DANCE FESTIVAL.
- 4. Your data will be processed in the following scope:
 - personal data of the Participant (child/adult participant), such as: name and surname, year
 of birth, image, address of the institution the participant attends;
 - personal data of the instructor/applicant such as: name and surname, e-mail address, telephone number, bank account number (accreditation payment);
- 5. If you provide an e-mail address or telephone number, they may be used by the Organizer to contact you in matters related to the organization of the Festival.
- 6. Providing data is voluntary, but necessary to achieve the purposes for which it was collected and without providing it, participation in the Festival will not be possible.
- 7. Your personal data will be processed for the period necessary to fulfill the purpose of processing in accordance with the institution's uniform objective list of files, JRWA, resulting from the Act of July 14, 1983 on the national archival resource and archives, no longer than 2 years, counting from the year following the end of the Festival or until withdrawal of consent, while data regarding accreditation will be stored for a period of 5 years, counted from the end of the year following the financial year.
- 8. Personal data, including the image of participants and instructors, may be made available in connection with the announcement of the results of the Festival and the award ceremony as well as the promotion of the Festival on the websites of the Gdynia City Hall and on the websites of Youth Community Center facilities, during events organized by the director of the Youth Community Center (e.g. public announcement of the winners' personal data, public presentation of the image a photo or Festival film) and on social networking sites such as YouTube and Facebook. We would like to inform you that YouTube and Facebook servers are located in the United States of America, where different personal data protection regulations apply.
- 9. Processed personal data may be transferred to, among others: entities which personal data must be made available to in order to fulfill a legal obligation, as well as entities to which the data will be entrusted to achieve the purposes of processing. (including accounting and financial services, suppliers of IT technical solutions, postal operator).
- 10. The personal data obtained will not be processed in an automated manner and will not be subject to profiling.
- 11. You have the right to: access the data, receive copies of it, rectify it if it is incorrect or out of date, limit processing, and the right to withdraw consent to processing at any time.
- 12. You have the right to lodge a complaint with the President of the Personal Data Protection Office, 00-93 Warszawa, 2 Stawki Street.
